Army Institute of Technology, Pune is run by Army Welfare Education Society registered on 29/4/1986 under society act XXI 1860, with the noble aim of providing quality education to wards of soldiers serving the armed forces of our country, whose wards could not get the domicile of a particular state, due to frequent postings and missions of the soldiers.


AIT is a private unaided institution affiliated to Savitribai Phule Pune University and is governed under the Maharashtra Public University Act 2016.

As per the order of the Hon Supreme court New Delhi on the writ no- 325/1994, as this Institute is established for the wards of service personal from Army, it is allowed to conduct its admissions independently for the wards of defense personnel purely by merit and not as per rules applicable to other affiliated Institutions in the state.

Based on the above judgment and Government of Maharashtra letter number F P O 2/B-2/RC[BB]/93 16th June 1994, AIT is exempted from the provisions of Single window admission process i.e state wise Common Entrance Test (CET) as required vide Maharashtra State Unaided Private Professional Education Institute (Regulation of Admission at Fees) Gazette Act 2015. As per this exemption and Supreme Court order referred above any reserved quota and Scholarship/ Tuition fees exemption from state government is **NOT** applicable for AIT.

The admissions in Army Institute of Technology, Pune is based on All India Ranking obtained in the **Joint Entrance Exam (Main) (JEE Main)** conducted by **National Testing Agency (NTA)** and some weightage is given for the **wards of disabled soldiers, War Widows and Gallantry Award winners** again as per Supreme Court ruling. Thus this Institute carries out 100% admissions through all India merit. Therefore the list of admitted students is not processed and approved by DTE.

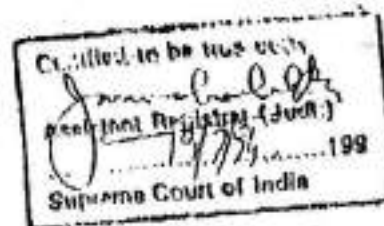

- (iii) any seats remaining unfilled by children of Armed Forces shall be surrendered forthwith to the government of Maharashtra who may be entitled to allot students in respect of those seats, who shall be charged the same fee of Rs. 5000/- p.a.

Remaining portion of the order shall remain unchanged.

The reliefs sought for in this petition are as follows :

"(a) Issue an appropriate Writ, Direction or Declaration declaring that the scheme contained in Pt. III of the Judgment of this Hon'ble Court reported in (1993) 1 SCC 645 (J.P. Unnikrishnan Vs. State of Andhra Pradesh) is inapplicable to the Army Institute of Technology and secondly issue a direction to the 1st respondent, All India Council for Technical Education to grant appeal for the establishment of the Army Institute of Technology.

(b) Alternatively pass orders directing that the petitioners are exempt from the scheme contained in Pt. III of the judgment reported in (1993) 1 SCC 645 (J.P. Unnikrishnan Vs. Government of A.P.) in so far as the establishment of the Army Institute of Technology is concerned; and

(c) Pass such or other orders as this Hon'ble Court may deem fit and proper in the circumstances of the case."

This petition is filed by the Army Welfare Education Society which provides education for the children of Army personnel including Ex-Servicemen.

Apprehending that the decision of this Court in J.P. Unnikrishnan Vs. State of Andhra Pradesh - 1993 (1) SCR 545 is likely to be made applicable to the petitioner this writ petition is filed for the aforesaid reliefs.

However, this Court on consideration of the matter and after hearing the parties made an order on 18.7.1994 having regard to the facts and circumstances of the case that the regulations framed by the All India Council of Technical Education (for short the 'AICTE') applicable to private Engineering Colleges shall not apply to this college and allowed the institution to start subject to certain conditions with reference to the fee to be charged by them and that position has continued even thereafter.

On the aforesaid basis now that the institution has started and has been functioning for over six years, that position should continue and it will not be proper to upset that state of affairs. It is made clear that the regulations framed by the AICTE shall not be made applicable either in relation to admission and charging of the fees, however subject to other aspects of the Rules such as recognition, maintenance of standards etc. It is unnecessary for us to make any direction with regard to the fee structure to be adopted by the institution because the object of the institution itself is to

provide for the welfare of the children of the Army personnel. In that view of the matter, we do not think any further order is required to be passed. The petition is disposed of accordingly.





- देशातील सैन्यदलात असलेल्या सैनिकांच्या पाल्यांना गुणवत्तापूर्ण शिक्षण मिळवणे वा घेवून तसेच सैनिकांच्या सैन्यदलातील मोडिबांमुळे त्यांच्या पाल्यांना विविध राज्याचे अधिवासघारक होता येत नाही. अधिवासघारक नसल्यामुळे या पाल्यांना प्रवेश मिळवताना अडचणी येतात ही याच विचारात घेऊन आर्मी वेल्फेअर एज्युकेशन सोसायटीची स्थापना २९ एप्रिल १९८३ रोजी झाली. देशभरात या

सोसायटीच्या १३ व्यावसायिक अग्रासंस्थांच्या संस्था आणि १२१ आणि स्कुल्स असून सुमारे १.५ लाख विद्यार्थी यामधून शिक्षण घेत आहेत.

- सदर संस्थेची नोंदणी सोसायटी ऑफ्ट ४०० १८६० अन्वये दिनांक २९.३.१९८३ रोजी झालेली असून संस्था खाजगी विनाअनुदानात स्वरूपाची जरी असली तरी या सोसायटीचे प्रशासन मंडळातील सदस्य हे Ex-Officio स्वरूपाचे असून Chief of Army Staff हे अध्यक्ष आणि उपाध्यक्ष म्हणून Vice Chief of Army Staff यांचेचोबर सैन्यदलाच्या सूत्र विभागाच्या मुख्यालयातील Commanding in Chief अशा स्वरूपाचे आहे.
- सदर संस्थेला शासन निर्णय उच्च व तंत्रशिक्षण आणि सेवायोजना विभाग क्रमांक पीईसी-२०९४/६४२४/तांशि-१, दिनांक ५.८.१९९४ आणि शासन निर्णय उच्च व तंत्रशिक्षण विभाग क्रमांक टीईएम-२०१५/१०२९/ प्र क्र २८४/ तांशि-४, दिनांक ३.६.२०१५ अन्वये परवानगी दिली असून दिनांक ५.८.१९९४ च्या शासन निर्णयात सदर संस्था खाजगी विनाअनुदानात संस्था म्हणून उल्लेखित आहे.

With reference to above, it is hereby stated that the AIT Pune has submitted an application to this Directorate on 31/3/2016. The said Institute is run by Army Welfare Education Society and has been registered under Society Registration act. Admissions to this Institute are based on merit for the wards of service personal and wards of the Army war widows throughout the country. These admissions are through the JEE (Marks) and 12th std marks (60 to 40% weightage) Recently govt. of Maharashtra passed an act for private unaided professional colleges in the state (Admission & Fees) Act 2015 dt 17/8/2015. Accordingly to the act the admissions are to be made through Common Entrance Test (CET). The said Institute (AIT) has requested for an exemption from admissions through CET. In this connection following points are mentioned.

The said Institute is run by Army Welfare Society for education needs of wards of Army Personnel thorough army welfare funds.

As the army personnel move to different posts of the country due to their job and hence their wards cannot get domiciles from a particular state and get the benefits of that particular state. To give high education to these wards, AWES was formed on 29 April 1983 so as to provide merit base education to all such wards. This AWES, runs total 13 professional colleges and 126 Army Public Schools throughout the country and approx. 1.5 lakh students are studying in these institutions

The said society is registered through society act XXI 1860 dt 29/4/1983. Even though the Institute is private un-aided, the member of the governing body of the said society are chief of Army staff as chairman and vice-chief of Army staff as ex-office on the management body.

The said Institute is approved by Govt of Maharashtra Higher and Technical Education dept on PEC-2094/(6421)/TE-1 dt 5/8/1994 & Govt decision Higher & Technical Education No-TEM02015/1029/Case No-281/TE-4 dt 3/6/2015 and is enrolled on private unaided Institute in the list of the educational Institute dt 5/8/1994.

This Institute is not and deemed university and is affiliated to the University of Pune as private un-aided Institute. Hence it is run as per the rules of the University act as applicable for affiliated colleges. However the educational fees of this Institute are not approved or decided by the shikshan shulka smiti. No Government scholarship is provided to this Institute. The student admitted at this Institute get AGIF (Army Group Insurance fund) scholarship and it is controlled by the head office at New Delhi. The students of this Institute get internship through Adjutant General Office New Delhi, Defence Ministry Govt. of India, DRDO etc.

Admissions to this Institute are made through the merit of JEE on all India bases. Thus this Institute carries out 100% admissions through all India merit. Therefore the list of admitted students is not processed and approved by DTE till date. If at all this Institute has to get the 100% admission for the A.Y 2016-17 through All India merit, then as in case of ICT Mumbai where 70% from Maharashtra quota and 30% from All India quota, on the same basis 100% admission to this Institute is to be done All India quota an approved by competent authority. However, for the same special provision will have to be made in the existing system of admissions, for this Institute. Because as per present rules for admissions, before conducting admissions for All India quota, CET quota of the state is to be exhausted & then JEE marks are be considered for admissions.

As per the order of the Hon Supreme court New Delhi on the writ no-325/1994, as this Institute is established for the wards of service personal from Army, considering this aspect the Institute is allowed to conduct the admissions independently and not as per rules applied to other Institutions. Also the Govt of Delhi has exempted the Army College of Medical science run by AWES, from the Delhi professional colleges or Institutions (Prohibition of capitalization fee, Regulation of Admission, Fixation of Non exploitative fee and other to ensure Equity and Excellence) (Amendment) Act 2013 (Delhi Act 07 of 2013) as informed vide Delhi govt. letter dated 13/9/2013. Considering this aspect, to exempt this Institute from the act of 2013 separate order are to be passed by the govt. exempting the Institute (AIT) otherwise the Institute cannot conduct the admission on their own.

The said Institute has already started its process for admission for the academic year 2016, & has already published its prospectus and procedure of admission. Hence the act of 2015 is made applicable to this Institute, without which the basic intention to run the Institute for wards of servicemen from Army and wards of the war widows cannot be fulfilled. Therefore the Institute has requested for exemption from the said act.

The said application submitted to this Directorate by the Institute is also forwarded to the govt. of Maharashtra on 17/3/2016.

AIT Pune established by the AWES is only for the wards of servicemen from Army only. It is run on the funds accumulated from the servicemen. AWES was established to give good academic education to the wards of these servicemen who serve on the border or at various places throughout the country. Admission of these wards cannot be done as in the case of other students. The society has established such Institutes all over India, so that while facing difficult situations in the Army life, their wards could get at least minimum basic infrastructure for professional education. For such noble cause this Institute has been functioning for last 21 years without making any profit. Therefore they have requested to get exemption so as to give admissions only on merit.

Considering the special constitution and composition of the Institute and its Governing Council, Directorate has no objection for the same. Single window for the unaided, private professional Institutes of state of Maharashtra are Governed by Admission and Fee Regulation Act of 2015 of 17/8/2015. However considering the above mentioned facts and to facilitate admissions of wards of soldiers, a notification to exempt AIT Pune for this act will have to be issued. In this context it is also mentioned that the MBA (Logistics Management) programme of Indian Navy's, INS Hamla, Marve, Malad (W) Mumbai, which is run for Navel personal and their wards, will also have to be exempted accordingly. It is hereby requested that the Govt. of Maharashtra may please take a policy decision for exemption of these Institutes from the 2015 act, while keeping in mind that the Institutes will be responsible for handling all the grievances, complaints, related to admission/fees will maintain proper transparency, and will ensure that proper merit, eligibility and consideration for special segments during admissions is kept in mind.


उपरोक्त विषयाबाबत संदर्भाधीन पत्रान्वये संचालक, तंत्र शिक्षण यांनी प्रस्तावित केल्यानुसार आर्मी वेलफेअर एज्युकेशन सोसायटी संघलित आर्मी इन्स्टिट्यूट ऑफ टेक्नॉलॉजी, पुणे या संस्थेस महाराष्ट्र राज्यातील विनाअनुदानित खाजगी व्यावसायिक शैक्षणिक संस्था (प्रवेश व शुल्क यांचे विनियमन) अधिनियम २०१५, दिनांक १७.८.२०१५ मधील एक खिडकी पध्दतीने राज्य सामायिक प्रवेश परीक्षेद्वारे प्रवेश करण्याची तरतूद तसेच सदर अधिनियमांतर्गत प्रसिद्ध करण्यात आलेल्या प्रवेश नियमात अखिल भारतीय कोट्यातून (All India Quota) प्रवेश करताना प्रथम राज्याच्या सामायिक प्रवेश परीक्षेच्या आधारे (सीईटी) व तदनंतर जेईई च्या गुणांच्या आधारे अशा प्राधान्याक्रमाने प्रवेश करण्याच्या तरतुदीबाबत अपवाद करून संस्थेला त्यांच्या प्रचलित प्रवेश प्रक्रियेप्रमाणे संस्थास्तरावर पूर्वीप्रमाणेच १०० टक्के अखिल भारतीय कोट्यातून प्रवेश करण्यास खालील मुद्दे विचारात घेऊन मान्यता देण्यात येत आहे :-

- देशातील सैन्यदलात असलेल्या सैनिकांच्या पाल्यांना गुणवत्तापूर्ण शिक्षण मिळावे तसेच सैनिकांच्या सैन्यदलातील मोहिमांमुळे त्यांच्या पाल्यांना विशिष्ट राज्याचे अधिवास्तधारक होता येत नसल्यामुळे या पाल्यांना प्रदेश मिळवताना अडचणी येतात म्हणून सैनिकांच्या पाल्यांच्या शैक्षणिक हितारतव आर्मी हेडक्वार्टरकडून तपलद्वय आर्मी वेलफेअर फंड्स मधून सोसायटी अॅक्ट

- XXI १८६० अन्वये दिनांक २९.४.१९८३ रोजी नॉदणीकृत आर्मी वेलफेअर एज्युकेशन सोसायटीमार्फत आर्मी इन्स्टिट्यूट ऑफ टेक्नॉलॉजी, पुणे ही संस्था चालविण्यात येते.
- सदर संस्थेला शासन निर्णय, उच्च व तंत्रशिक्षण आणि सेवायोजन विभाग, क्रमांक पीईसी-२०९४/(६४२१)/तांशि-१, दिनांक ५.८.१९९४ आणि शासन निर्णय, उच्च व तंत्र शिक्षण विभाग, क्रमांक टीईएम-२०१५/१०२९/ प्र क्र २८१/ तांशि-४, दिनांक ३.६.२०१५ अन्वये मान्यता देण्यात आली असून सदर संस्था खाजगी विनाअनुदानित स्वरूपाची जरी असली तरी या सोसायटीचे प्रशासन मंडळातील सदस्य हे Ex-Officio स्वरूपाचे असून Chief of Army Staff हे अध्यक्ष आणि उपाध्यक्ष म्हणून Vice Chief of Army Staff यांचेबरोबर सैन्यदलाच्या सर्व विभागाच्या मुख्यालयातील Commanding in Chief अशा स्वरूपाचे आहे.
 - सदर संस्था पुणे विद्यापीठाशी संलग्नीत खाजगी विनाअनुदानित स्वरूपाची संस्था आहे. परिणामी ही महाराष्ट्र विद्यापीठ कायदयानुसार संलग्नीत महाविद्यालयाप्रमाणे नियंत्रित केली जाते. मात्र त्या संस्थेने शैक्षणिक शुल्क राज्याच्या शुल्क नियामक प्राधिकरण (पूर्वाश्रमीची शिक्षण शुल्क समिती) यांचेकडून मान्य करून घेतले जात नाही.
 - या संस्थेत राज्य शासनाकडून शिष्यवृत्ती अथवा शिक्षण शुल्क प्रतिपूर्ती देण्यात येत नसून प्रवेशित विद्यार्थ्यांना AGIF (Army Group Insurance Fund) द्वारे शिष्यवृत्ती देण्यात येते व त्याचे नियंत्रण नवी दिल्ली येथील कार्यालयातून होते.
 - या संस्थेकडून जेईई (मेन्स) आणि इयत्ता १२ ची ध्या गुणांच्या (६०:४० वेटेज) आधारे १०० टक्के प्रवेश अखिल भारतीय कोटयातून संस्थास्तरावरून केले जातात. त्यामुळे आतापर्यंत संस्थेची प्रवेश यादी तंत्र शिक्षण संचालनालयाकडून पडताळणी करून प्रमाणित केली जात नाही. सव्व सदर संस्थेचा मूळ हेतू लक्षात घेता, संस्थेला शैक्षणिक वर्ष २०१६-१७ पासून अशाच प्रकारे १०० टक्के प्रवेश अखिल भारतीय कोटयातून संस्थास्तरावरून करावयास, महाराष्ट्र राज्यातील विनाअनुदानित खाजगी व्यावसायिक शैक्षणिक संस्था (प्रवेश व शुल्क यांचे विनियमन) अधिनियम २०१५, दिनांक १४.८.२०१५ अंतर्गत प्रसिध्द केलेल्या प्रवेश नियमातील तरतूदीतून सूट देऊन, मान्यता देणे गरजेचे आहे.
 - सदर संस्थेच्या बाबतीत मा. सर्वोच्च न्यायालय, नवी दिल्ली यांनी रिट याचिका क्रमांक ३२५/१९९४ मध्ये दिलेल्या आदेशानुसार सदर संस्था विशेषतः सैन्यदलातील सैनिकांच्या चाल्यांसाठी प्रवेश करत असल्याने इतर सरथाना लागू असलेली प्रवेश प्रक्रिया राबविण्याऐवजी या संस्थेला स्वतंत्रपणे प्रवेश करण्यास परवानगी देण्यात आलेली आहे.
 - तसेच दिल्ली राज्याने निर्धारित केलेल्या Delhi Professional Colleges or Institutions (Prohibition of Capitation Fee, Regulation of Admission, Exaction of Non-Exploitative Fee and Other Measures to Ensure Equity and Excellence)(Amendment) Act, २०१३ (Delhi Act ०९ of २०१३) मधून आर्मी वेलफेअर एज्युकेशन सोसायटीच्या आर्मी कॉलेज ऑफ मेडिकल सायन्सेस संस्था अपवाद म्हणून वगळण्यात आलेली आहे व तशी अधिसूचना राजपत्रात दिनांक १३.९.२०१३ रोजी प्रसिध्द करण्यात आली आहे.

- या संस्थेने शैक्षणिक वर्ष २०१६-१७ मधील प्रवेशाबाबत यापूर्वीच कार्यवाही सुरु केली असून त्याचे माहितीपत्रक व प्रवेशाची कार्यपध्दती याआधीच प्रसिध्द केलेली आहे त्यामुळे उक्त अधिनियमानुसार कार्यवाही करावयाचे झाल्यास सोसायटीने ज्या हेतूने सदर संस्था सुरु केली आहे त्या सैन्यदलातील सैनिकांचे पाल्य व युध्दात वीरमरण आलेल्यांच्या विधवांचे पाल्य यांना गुणवत्तापूर्ण शिक्षण देण्याचा उदात्त हेतू पूर्ण होणार नाही म्हणून संदर्भाचीन अधिनियमातून अपवाद करण्यास संस्थेने विनंती केली आहे.

२. तसेच, संचालक, तंत्र शिक्षण यांनी प्रस्तावित केल्याप्रमाणे आर्मी इन्स्टिट्यूट ऑफ टेक्नॉलॉजी, पुणे या संस्थेस उपरोक्त वस्तुस्थितीच्या आधारे ज्याप्रमाणे मान्यता देण्यात येत आहे त्याचप्रमाणे मुंबई विद्यापीठाशी संलग्नित भारतीय नौदलाच्या INS हमला, मार्बे, मालाड (पश्चिम), मुंबई या संस्थेसही सदर अधिनियमातून अपवाद म्हणून वगळण्यास मान्यता देण्यात येत आहे.

Subject: Regarding exclusion of the Army Institute of Technology, Pune from the provision of admission through Common Entrance Test as per the provisions of the Maharashtra State Unaided Private Professional Educational Institutions (Regulation of Admission and Fees) Act 2015, dated 17.08.2015.....

Ref: Director, Technical Education's letter no. 2A/ADM/2016/456, dated 05.04.2016.

As proposed by the Director Technical Education vide above letters, AWES run AIT Pune is exempted from the provisions of

- (a) Single window admission process through state wise common entrance test as mentioned vide Maharashtra State Unaided Private Professional Education Institute (Admission at fee regulatory) Gazette Act 2015.
- (b) Also the requirement of first filling up the State quota through CET and then all Indian Quota based on JEE marks.

This exemption is approved due to the following aspects.

1. AIT, Pune is run by AWES registered on 29/4/1986 under society act XXI 1860, with the noble aim of provided quality education to wards of soldieries serving the armed forces of the country, whose wards could get the domicile of a particular state, due to missions and posting of the soldiers.
2. The said Institute has obtained Govt. approval vide Higher and Technical Education and services Planning and Department No. PEC 2094/(6421)/Tanishi-1 dated 05/0//1994 and Higher and Technical Education Department No-TEM-2015/1029/Parkr 281/Tanishi-4 dated 03/06/2015, although said Institute is Private, non-aided organisation, the members of the Governing body of this society are ex-officio and Chief of Army Staff is the Chairman and Vice Chief of Army Staff is the Vice Chairman and other members of Commanding Chief of all Commands.

3. The said institution is a private unaided institution affiliated to Pune University. Consequently this Institute is governed as an affiliated college under the Maharashtra University Act. But that institution does not accept the regulations of State Fee Regulatory Authority (Previous Education Fee Committee).

4. This institute is not provided any scholarship or tuition fee reimbursement by the state government, but scholarship is given to the admitted students by AGIF (Army Group Insurance Fund) and it is controlled from the office in New Delhi.

5. 100% admissions from this Institute are made from All India Quota based on JEE (Mains) and Class 12th (60:40 weightage) till now the admission list of this Institute is not validated and approved by DTE. Considering the original objective of the Institute an approval for exemption from provisions of Maharashtra State, Unaided Private Professional Educational Institute Act of 2015, is required to enable 100% admission from All India Quota from the A.Y 2016-17.

6. As per the order passed by the Supreme Court, New Delhi in Writ Petition No. 325/1994, since the said institute specifically admits the wards of soldiers in the armed forces, instead of following the admission procedure applicable to other institutes, this institute has been allowed to conduct entrance exam separately.

7. As Army Welfare Education Societies' Army College of Medical Science has been excluded as an exemption from Delhi Professional Colleges or Institutions (Prohibition of Capitations Fee, Regulation of Admission Eixation of Non-Exploitative Fee and Other Measures of Ensure Equity and Excellence) (Amendment) Act enacted by the State of Delhi 2013 (Delhi Act 07 of 2013) and the notification has been published in Gazette dated 13.9.2013

8. The Institute has already started the process for admission for A.Y 2016-17 and has published the brochure and notice for admission process of the Maharashtra State Act of 2015 is imposed upon the Institute. Unless exempted objective of the Society and Institution to provide quality education to the wards of soldiers and war widow's candidate cannot be achieved, hence the Institute has requested for exemption from this act.

9. Also as the approval for such exemption is being granted to AIT, as proposed by DTE, similar approval may also be granted for INS Hamala, Marve, Malad (West) Mumbai.
