AGIF SCHOLARSHIP SCHEME

1. Keeping in view financial health of ex-servicemen/ serving JCOs/OR and expensive higher technical /professional education, Army Group Insurance Fund (AGIF) has introduced a scholarship scheme wef Academic Year 2012-13. An amount of Rs 40,000/- per student per annum will be paid through NEFT/cheques drawn on the name of parent/legal guardian (in case of demise of AGIF member) of the selected students.
2. The eligibility conditions for award of this scholarship would be as under:-
 - (a) Only wards of serving/ex-servicemen Offrs and JCOs/OR who are/ have been members of the AGIF will be covered under this scholarship scheme.
 - (b) The scholarship will be admissible from the first year of admission which will be based on the percentage of marks scored in the 10+2 level examination. Subsequent year's scholarship will be awarded based on the performance of the student in the preceding year.
 - (c) Scholarship would be applicable for the current year only and for every subsequent years, fresh application is required.
 - (d) Scholarship amount will be remitted once in a year during the month of Apr to the parent/legal guardian (in case of AGIF member) of the students.
 - (e) Total 24% i.e 302 vacancies for the subject scholarship have been allotted to AIT.
 - (f) Students who are selected for award of DLF Raghvendra Scholarship or any other major scholarship will not be eligible for grant of AGIF scholarship.
 - (g) **It is mandatory to pass in all subjects** in the affected academic year i.e preceding year to be eligible for award of AGIF Scholarship.
3. **Percentage Reserved.** Distribution of 24% vacancies for the scholarship are as under:-

(a) Reserved for wards of Officers	-	6%
(b) Reserved for wards of JCOs/OR	-	10%
(c) Reserved for Girl wards of JCOs/OR	-	08%
4. **Cut Off Percentage.** The minimum percentage of marks required to be eligible to apply for scholarship would be as under:-

(a) Wards of Officers	-	65%
(b) Wards of JCOs/OR	-	63%
(c) Girl Wards of JCOs/OR	-	60%
5. Application forms for award of subject scholarship are available with Institute's Xerox Centre. Eligible students may get application forms from Xerox Centre.
6. Documents required to be attached with the application form are as under:-
 - (a) Cancelled Cheque of parents' bank account (compulsory for all scholarships).
 - (b) Photocopy of last year marks sheet duly attested.

- (c) Parents income certificate duly signed by Tehsildar/Bank manager where applicable. Please refer scholarship policy.
- (d) Proof of Father's/Mother rank in the Army.(Serving certificate and attested photocopy of PPO of retired Army personnel as applicable).
- (e) Attested photocopy of 10th/ 12th marks sheets (Applicable to FE students only).
- (f) Attested photocopy of 10th/12th Board Certificate as proof of date of birth.
- (g) Attested photocopy of student Identity card.
- (h) Attested photocopy of JEE (Main) result. (Applicable to FE students only).
7. Students are required to submit completed application forms to their respective HsOD by **31 Aug 16**. No application form will be entertained thereafter. **Application forms will NOT be received directly at the offices of the Joint Director, Chairman Scholarship Committee, Registrar or Main Office.**
8. Students who have applied for revaluation of marks are advised to inform Chairman of the Scholarship Committee through their respective HsOD within 03 days of declaration of revaluation results with a copy of the result/mark list, **duly authenticated by the Registrar, AIT or Head of the Department**. No representation will be entertained later on. **Prof RS Verma, Mechanical Engineering Department** has been detailed as Chairman Scholarships Committee (for all Scholarships) for the Academic Year 2016-17.
9. All HsOD are requested to compile application forms of their respective Dept and submit the same duly completed in all respects to the Chairman /Presiding officer of the Scholarship Selection Committee by **20 Sep 16**.
10. The final list of awardees of AGIF Scholarship will be published on receipt of intimation from AGIF, likely by end Mar 2017.
